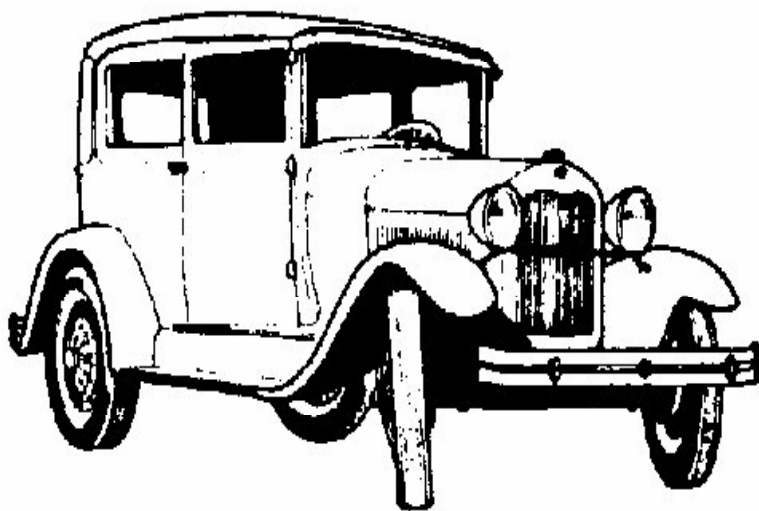

CONSTITUTION AND BY - LAWS

Article I

Name

Section 1. The name of the club shall be "Penn-Ohio 'A' Ford Club Inc."

Article II

Purpose

Section 1. The general purpose shall be to encourage the members to acquire, preserve, restore, and make use of the Model "A" Ford vehicle, model years 1928-1931 and all things pertaining to the Model "A" Ford, including literature, technical and historical information, and to promote the introduction of ideas and fellowship among its members.

Article III

Membership

Section 1. REQUIREMENTS. Any person interested in the purpose of this club is eligible for membership.

Section 2. DUES. Dues are payable annually on November first for the next year. Dues not remitted by December 31st of the preceding year are to be considered delinquent and membership will be suspended. (Rev. 11/00) This revision is to take place for the year 2002. Annual dues will be \$25.00 per year for chapter affiliated members and dues will be \$30.00 per year for non-affiliated members. (Rev. 04/14) The annual dues will be accepted as payment for joint membership for husband, wife, and children under 16 years of age. Children will receive membership cards only if requested. Dues are charged for a calendar year, except for members paying dues in November and December. They shall be entitled to membership for the ensuing year.

Section 3. PRIVILEGES. Members are entitled to all club privileges and shall have the right to vote and hold office.

Section 4. INSURANCE. All members shall be insured individually. The club is not responsible for the acts of a member or members' vehicles and action cannot be brought against the club for a members' careless act for any reason.

Section 5. EXPULSION. Expulsion of a member can be made only by unanimous vote of the Executive Board for conduct in which, in the opinion of the Board disturbs the order, dignity, business, or harmony or impairs the good name, popularity, welfare, interest, or character of the organization of the club. A unanimous affirmative vote of the Executive Board shall be required for rein-

statement or membership and privileges following expulsion.

Article IV Officers

Section 1. NUMBER OF OFFICERS. The elected officers of this Club shall be a Director, Secretary, Treasurer and Salesman. Officers shall each serve one year or until their successors are elected. In the event of the absence of the Director at an official Penn-Ohio meeting, the members present shall elect a temporary Chairman for the purpose of conducting the meeting.

Section 2. NOMINATION AND ELECTION OF OFFICERS. The Executive Board shall serve as a nominating committee and submit at least one candidate for each office at our Spring Banquet Meet. The membership may nominate candidates from the floor at the Spring Banquet Meet for each office. When more than one candidate is nominated for an office, voting will be done by written ballot. A committee appointed by the Director from current board members will count the ballots at the meet and announce the results. When only one candidate is nominated for each office, a hand vote will be conducted. Penn-Ohio members in attendance at the Spring Banquet Meet will vote on the nominated candidates. A member is a dues paying husband and wife and/or a single person, age 16 or older. (Rev. 03/05)

Article V Duties of Officers

Section 1. DIRECTOR. The Director shall preside at all business meetings and shall be chief executive officer. The Director shall insist upon enforcement of all objects, purposes, and provisions set forth in this Constitution and such other rules, regulations or by-laws of this club. The Director shall make a periodic verification of the deposits and withdrawals where the Club has any funds to determine the correctness of the balance to the credit of this organization. It shall also be the Director's duty to initiate the meet registration fee, the request for money donation from each chapter for raffle prizes and the split of 50/50 of the raffle ticket sales when the treasurer indicates that such measures are necessary. (Rev.11/93) The Director shall have the power to organize, dissolve, or reorganize committees. The Director shall have the power to appoint committee chairmen and also the right to discontinue the service of any chairman at any time.

Section 1A. ASSOCIATE DIRECTOR. The Associate Director shall be appointed in the second year of the Director's term. The Associate Director shall assist the Director, and in this function, shall be educated in the duties of the Director. The Associate Director would then be expected to place their name in nomination to succeed the present Director when such vacancy occurs. This position in itself does not entitle the person holding this position to be on the Executive Board. (Rev. 11/00)

Section 2. SECRETARY. The Secretary shall be in charge of all correspondence

for the Club. The Secretary shall be responsible for the taking of minutes at all business meetings and shall see to the proper filing and distribution of such minutes. An annual report of all additions and changes to the Constitution and By-Laws enacted in the previous year are to be sent to all chapter presidents by the Secretary. Also all future issues of the Penn-Ohio Roster will include an update of the Constitution and By-Laws.

Section 3. TREASURER. The Treasurer shall be responsible for the collection of dues for the Club and shall see to the proper accounting of all Club money. The Treasurer shall be responsible for the preparation and presentation of a detailed financial report and accounting of all Club money at any business meeting. When the difference between the income and expenditures of a proposed budget shall cause the treasury to fall below \$15,000.00 for that budget year, the treasurer shall notify the Director. The Director, with the approval of the Executive Board, shall initiate revenue-creating or cost cutting procedures. (Rev. 11/05)

Section 4. SALESPERSON. The Club Salesperson shall be in charge of all club merchandise and have some display at all club activities. The Salesperson shall be allowed to have a checking account with no penalties or checking fees. The Director, Treasurer and Salesperson shall mutually decide the balance to be held in the checking account. All monies above this amount shall be given to the Director and Treasurer including the inventory, sales and checking account balance. (Rev. 11/02)

Section 5. EDITOR OF PUBLICATION the "*A*" QUAIL CALL. The editor of this publication will be appointed by the Executive Board. The editor will give a report at each Executive Board meeting and will be a non-voting member of the Executive Board per Rev. 2/99. The Editor shall be paid a salary determined by the Executive Board. (Effect. 3/03)

Section 6. DUTIES OF OFFICERS. Penn-Ohio "A" Ford Club Officers are expected to attend both Executive Board Meetings each year. Any officer that misses both Board meetings during a calendar year is excluded from holding any Penn-Ohio office for a period of 24 months following the current year. The Director may excuse an officer from one or both Board meetings during the year for health or hardship reasons without penalty. (Rev. 03/05)

Article VI

Executive Board

Section 1. The Executive Board shall consist of the Director, Club Secretary, all past Club Directors, and the President and Secretary (or two duly appointed representatives) of each authorized Chapter now or in the future organized under this club. The past Club Directors and the President and Secretary (or two duly appointed representatives) of each authorized chapter shall each have one vote on all issues brought before the Executive Board. The Director shall be the Chairman of the Board, the Club Secretary shall be the Secretary of the Board,

and each will be a non-voting member. (Rev. 2/99)

Section 1A. Past Directors may resign by informing the Club Director of their intention. Any Past Director who misses two consecutive regularly scheduled Executive Board meetings will be dismissed from the Executive Board. (Rev. 11/08) Any Past Director who permits their membership to lapse and then rejoins the Club shall not serve on the Executive Board again unless they serve another term as the Director (Rev. 2/99), or are serving as President, Secretary, or duly authorized representative of a chapter. (Rev.3/00)

Section 2. The Director may call the Board together to transact Club business when Club business warrants, but all Chapter delegates and all Board Members must have a two-week advance notice of such meetings.

Section 3. The Executive Board shall meet in November each year and as needed to conduct the business of the club as indicated by the Director at a centrally located place so every member attending will have approximately the same distance to travel. They shall draw up the proposed program for the coming year. (Rev. 11/07)

Section 3A. All items being submitted for consideration by the Executive Board agenda shall be in the hands of the Director no later than September 15th. The Club Secretary shall then have the agenda out to each Executive Board member by the first of the month preceding the Executive Board meeting. (Rev. 11/07) This would give the chapters an opportunity to vote on all items prior to the Board Meeting.

Section 4. The Executive Board shall have the power to hear and determine the facts regarding any disputes, protests, or complaints arising in the jurisdiction of the Club. It shall have the power to cite before it any member and to inspect the records and/or papers pertaining to any case hearing. Thereon, the decision of the Board shall be final.

Section 5. The Executive Board shall approve all transactions of business of the club. The Board shall manage the affairs of the Corporation.

Section 6. There shall be no recording devices permitted at Penn-Ohio Executive Board meetings.

Article VII **Committees**

Section 1. APPOINTMENT OF COMMITTEES. The Executive Board shall appoint such committees as it finds desirable from time to time and shall outline the duties and responsibilities of such committees. There shall be a Finance Committee appointed by the Director. The duties of this committee shall be to set up and supervise the budget and to provide and supervise means of earning money if needed.

Article VIII

Chapter Organization

Section 1. FORMATION OF CHAPTERS. In order to carry out the purpose of this Club effectively, the Director, with the approval of the Executive Board, may create from time to time Penn-Ohio "A" Ford Club, Inc. Chapters, defining their geographical limits and functions. The governing rules of these Chapters shall be in accordance with the Constitution and By-Laws.

Section 2. Existing Chapters may be subdivided, changed, or dissolved by action of the Executive Board.

Section 3. ADMINISTRATION OF CHAPTERS. Each Chapter shall elect annually a President, Secretary, Treasurer, or any other officer so desired. These officers shall conduct the affairs of the Chapter in accordance with this Constitution and By-Laws. The Chapter President and Chapter Secretary shall, during their full terms of office, be members of the Executive Board. A Chapter must have a minimum of ten members to be sanctioned by the Executive Board. Such Chapters may finance their own activities and regulate their own affairs, including, but not limiting to Chapter dues.

Section 4. At no time shall an individual Chapter schedule an event that conflicts with an official Penn-Ohio "A" Club, Inc. meet.

Section 5. MEMBERSHIP IN CHAPTERS. A prerequisite for membership in a Penn-Ohio Chapter is a payment of current Penn-Ohio "A" Ford Club Inc. dues.

Article IX

Meets

Section 1. SPRING BANQUET. The Spring Banquet shall be held the third Sunday in May each year for the purpose of electing Club Officers. (Rev 4/14) This meeting shall be in the form of a dinner meeting at the individual member's expense. It shall be in a suitable place for the seating and feeding of all members expected to attend.

Section 2. AWARDS BANQUET. The Awards Banquet shall be an annual event held on the third Sunday in the month of October (Rev 4/14). This meeting is designated to the awarding of trophies.

Subsection A. ATTENDANCE AWARDS. Penn-Ohio will provide an additional attendance plaque at no charge to those members who have filled their plaques. (Rev 2/95) Attendance Awards will be presented as follows:

PERFECT ATTENDANCE AWARD. This award is given to members who drive a Model A or modern vehicle and register at all the Penn-Ohio Ford "A" Club Inc. meets. Eligibility for perfect attendance does not require attendance or registration at the Penn-Ohio Tour. Any member driving a Model A to all Penn-Ohio meets will be awarded "A" Perfect Attendance Award. (Rev. 11/01)

ATTENDANCE AWARD. This award is given to members who drive and register at any five (5) of the sanctioned Penn-Ohio meets. (Rev.

3/00) Attendance and registration at the Penn-Ohio Tour does not count toward this award.

CHAPTER ATTENDANCE. Recognition will be given to the Chapter that had the largest number of members that drive and register their Model “A” Fords to Penn-Ohio meets through the regular previous driving season.

Subsection B. DISTANCE AWARDS. Individual driving awards will no longer be recognized. (Rev. 03/06) Mileage will still be tracked for chapter recognition only. The mileage for ONE-DAY meets is for the distance from the member’s residence to the meet, and DOES NOT include any side trips taken to arrive at the meet. The mileage for a TWO-DAY meet is for the distance from the member’s residence to the origin of the hosting chapter start of the first day. The mileage for the planned activities of the hosting chapter for the day, return to hotel/motel and from the hotel/motel to the meeting place for the hosting chapter’s second day is also to be counted. This DOES NOT include any mileage for side trips taken by a member or a member’s chapter. Mileage will be taken from the official registration book. (Rev. 11/01)

Subsection C. The Awards Banquet will count as the first meet of the coming season.

Section 4. ASSIGNMENT OF MEETS. The sanctioned regular meets shall be assigned at the November and March Executive Board Meetings. (Rev. 2/99) Each chapter will designate its own place and time.

Article X

Club Publication

Section 1. NAME OF PUBLICATION. The name of the publication of the Penn-Ohio “A” Ford Club Inc. shall be the “A” *QUAIL CALL*.

Section 2. FREQUENCY OF PUBLICATION. The “A” *QUAIL CALL* shall be published nine (9) times a year. (Rev. 11/13)

Section 3. Those organizations or chapters placing a flyer in the “A” *Quail Call* shall make a \$10.00 donation to the club, which will in turn be paid to the Quail Editor. Penn-Ohio related flyers (e.g. Penn-Ohio Swap Meet) would be exempt.

Section 4. PURPOSE OF PUBLICATION. The purpose of the publication shall be to promote the ideas set forth in Article II, Section 1 of this Constitution.

Section 5. FINANCIAL REPORT. A complete financial report shall be published in the “A” *QUAIL CALL* at the beginning of each year.

Section 6. All monies collected from the “A” *Quail Call* “back page advertising” will first cover the expense of printing the Penn-Ohio membership directory and constitution & by-laws. Funds exceeding this expense can be applied to updates or improvements of Penn-Ohio Model A website. This decision shall be made by the Director’s approval. (Rev. 11/13)

Article XI

Fiscal Year

Section 1. The Fiscal Year of the Club shall be the Calendar Year.

Article XII

Principal Office and Seal

Section 1. PRINCIPAL OFFICE. The principal office of this Club shall be maintained at the office of the Director.

Section 2. OTHER OFFICES. Branch or Subordinate Offices may be established at any time by the Executive Board, or by majority vote.

Section 3. SEAL. The Executive Board shall provide a Corporate Seal, which shall be in the form of a rectangle with the joint maps of the States of Pennsylvania and Ohio and shall have inscribed thereon the name of the corporation.

Article XIII

Amendments

Section 1. MANNER OF AMENDMENTS. Amendments or acts to the repeal of this Constitution, By-Laws, or any rules or regulations may be made at any business meeting by two-thirds majority vote of the members present. (Rev. 01/93)

BY - LAWS

Membership

- A. Penn-Ohio members can join as many Chapters as they wish as long as they are accepted by the Chapter.
- B. If a member of more than one chapter, registration shall be under the chapter to which Penn-Ohio dues are paid. (Rev. 11/02)
- C. Any member in good standing that wants anything put on the agenda of an Executive Board Meeting can do so by submitting it in writing to the Director.
- D. All Chapter members must belong to the Penn-Ohio "A" Ford Club Inc. Non-Affiliated and Associate members belong only to Penn-Ohio and do not participate in any Chapter activities.
- E. Any member's car that breaks down on the way to a sanctioned meet can be registered and paid for by a fellow member and can be counted present for the meet.
- F. The membership list is not to be released to any outsider.
- G. To recognize members for continuous and/or accumulative years of membership, a pin shall be awarded every five years, starting with five (5) years accumulative membership. (Rev. 11/00) A pin is to be awarded to both the husband

and the wife for the years of membership. (i.e. two pins are awarded.) Pins are only awarded through (40) years of continuous and/or accumulative years. No pins will be awarded after (40) years of continuous and/or accumulative membership. Any member not paying their dues on or before December 31st of said year shall lose their continuous membership. If dues are late or a year is missed, the member shall submit proof of membership along with a request to the Penn-Ohio Secretary to have the years count as accumulative. If a member is late paying due to hardship reasons, the member shall request in writing to the Executive Board for consideration for continuous member status. At 45 years of continuous membership, the member will pay one half the Penn-Ohio dues until fifty years of continuous membership is achieved then a lifetime award of no Penn-Ohio dues will be given. These awards will not be given for accumulative years. (Rev. 4/14)

H. All members must drive their Model "A Fords to and from the meet in order to participate in the events.

I. In case of the death of a Penn-Ohio member, the President of the Chapter to which that member belonged shall notify the Director. The Director will in turn notify other Chapter Presidents as directed. The name of the deceased member will be added to a "Memorial List" to be published in the May issue of the "A" *Quail Call*. It will be the responsibility of each chapter to supply the names of the deceased members to the "A" Quail editor. (Rev. 11/98)

J. **Honorary membership** will have Penn-Ohio waive the club dues for a period of two years following the year the member died as an Honorary membership for the surviving spouse. This will be on the member's chapter's recommendation in case a surviving spouse does not want to continue as a member. All widows whose spouse has died prior to the implementation of this change will continue to receive a membership for the previously set five years. (Rev. 2/99) All widows whose spouse has passed away from January 1982 through January of 1999 are eligible for the five-year exemption of Penn-Ohio dues. (Rev. 2/99) If a chapter wishes to extend this membership beyond the five-year period (for those who died from January 1982 through January 1998) (Rev. 2/99) they can fund it at one half the current Penn-Ohio dues.

K. Any **NEW MEMBER** that joins the club between January first and August 31st and pays the full year dues payment at that time will make that person eligible to be counted as a complete year of membership towards a continuous membership pin award. For example if the member joined on 6/15/00 they would receive ten-year award in 2010. (Rev. 11/00)

Chapters

A. All Chapters are expected to take turns at hosting sanctioned Penn-Ohio "A" Ford Club Inc. meets. The Chapter, which has not hosted a meet for the longest period of time, shall have first choice of assignments if it is requested by October of the previous year. A meet can be assigned at either the Spring or Fall Executive Board Meeting.

B. The hosting Chapter of each meet will supply the official registrar. Only the

official registrar will enter information on the registration book.

C. The hosting Chapter will stand for all expenses incurred in hosting the meet. The exception will be for the registration prizes. (Rev. 4/09)

D. All Chapters who host sanctioned meets shall supply an article and pictures about the meet to the "A" *QUAIL CALL*. The article shall be submitted by the 5th of the month following the meet. (Example: The article and pictures of the April Meet should be submitted by May 5th.)

E. The use of a Chapter's name cannot be granted by anyone.

F. No Chapter shall be admitted to the Penn-Ohio "A" Ford Club Inc., which falls outside the Penn-Ohio area.

G. A Chapter may hold a swap meet in the same month as the Penn-Ohio "A" Ford Club Inc. Swap Meet but cannot schedule it on the same day or use the Penn-Ohio "A" Ford Club Inc. name.

H. No absentee vote will be accepted at the Executive Board Meetings.

Insurance

A. The Penn-Ohio insurance policy does not cover your car in an accident that takes place during a Penn-Ohio tour, travel to a Penn-Ohio meet or an individual chapter tour or event. Your car and its occupants are covered only under your personal car insurance policy. Your insurance coverage for your Model "A" should be the same as your modern car with regard to bodily injury, property damage and medical payments. You should also have underinsured/uninsured coverage.

B. Coverage for an individual chapter holding a Penn-Ohio event must be submitted to the insurance company in advance of that event for approval. Forms will be supplied by the Penn-Ohio Club Secretary.

C. Coverage for an individual chapter holding a NON Penn-Ohio event, must be submitted to the insurance company in advance for approval. The chapter must obtain the forms from the Penn-Ohio Secretary. You **MUST NOT ASSUME** your NON Penn-Ohio event is covered by the insurance company.

D. In general, the Penn-Ohio Club insurance protects the club when causing damage to facilities we rent for our events. Penn-Ohio insurance protects against injury to the general public and club members, unless they are negligent, while on the rented premises during the club event. The insurance also bonds all members who collect and handle money for our treasury and the Tour Master.

E. The Tour Master shall put on the first page of the directions for the Penn-Ohio Tour the following and should announce the following in any instructions given verbally before the Tour begins: All traffic laws will be obeyed by all members on tour (i.e. Traffic signals, speed limits and any signs on any roads traveled on the Penn-Ohio Tour). This would be a good thing for all tours run by a local chapter.

Regular Meets

A. There will be five (5) sanctioned meets per year, unless a Penn-Ohio Tour is held. The Penn-Ohio Tour is not a sanction meet and will not count towards an

attendance award but will count toward the eligibility requirements to have your car judged at the Judging Meet (if held). Meets will be held in May (Spring Banquet), June (Tour if held), July, August, September and October (Awards Banquet). (Rev. 4/14)

B. Two of these meets are annual events: the Spring Banquet, and the Awards Banquet. This is in accordance with the Constitution, Article IX, Sections 1, 2, and 3.

C. The Penn-Ohio Tour will be held during the third week in June. The tour will no longer be considered as credit to a chapter for hosting a meet. (Rev. 11/07)

D. Meets such as Poker Runs and Car Games shall be regulated by the host chapter. (Rev. 11/01)

E. If there is a Road Rally, the occupants of a Model "A" participating in the Road Rally shall be limited to the driver, a navigator, and any children living at home.

F. The Registration Fee at all sanctioned meets, when collected, shall be \$1.50. (Rev. 11/93)

G. Registration Prizes will be given at each sanctioned meet. Any person that pays the registration fee (when collected) and registers at the meet in person is eligible for the prize. It is not necessary for the person to be present for the drawing. (Rev. 11/93)

H. There will be a raffle at each meet. Tickets will sell for \$.25 each or five (5) for \$1.00. Chapter members and the public may donate other prizes. The proceeds from the raffle shall be returned to the host Chapter until such time as ordered by the director to divide the proceeds evenly between the host chapter and the Penn-Ohio "A" Ford Club Inc. (Rev. 11/03)

I. The Director will notify Chapter Presidents as soon as possible if there is a change in a meeting place or date.

J. There shall be no open alcohol containers in any vehicle during any club activity.

K. All monthly meets, except the Spring and Awards Banquet, will be scheduled to take place on the third Sunday of the month. The time of the event is scheduled at the discretion of the Chapter. The hosting Chapter may request a variance to the third Sunday rule. The request for variance must be submitted in writing to the Director of Penn-Ohio. In turn, the Director of Penn-Ohio must request approval via vote of the Chapter Presidents. Each chapter will cast two votes and the majority yes/no votes will determine the approval or rejection of the variance. At the discretion of the Director, the voting procedure may be conducted at the Executive Board Meeting, via mail, or phone. (Rev. 11/94)

L. Registration at all sanction meets to be from 9:00 a.m. to 1:00 p.m. (Rev. 11/96)

M. At each club event, during the driving season, the host Chapter may hold a 50/50 raffle. The proceeds of these sales are to be directed by each individual Chapter. Each Chapter must be responsible for the supply of tickets and prizes for the raffle or raffles. (Rev. 11/03)

N. Penn-Ohio will no longer pay for dash plaques or trophies for Penn-Ohio meets. (Hosting chapters may provide trophies or any other awards at the hosting chapter's expense.) (Effect. 4/09)

Judging

Until such time as a Chairman and Judging Committee can be permanently appointed and assumes responsibility and re-establishes standards and procedure, the September meet will become a regular meet as with May, June (in absense of tour), July and August hosted by revolving Chapter assignment. (11/09)

Salaries

- A. CLUB SECRETARY: salary increase from \$300.00/year to \$800.00/year. (Rev. 11/00)
- B. CLUB TREASURER: salary increase from \$300.00/year to \$800.00/year. (Rev. 11/00)
- C. QUAIL EDITOR: salary increase from \$150.00/issue to \$205.56/issue. (Rev. 11/00) They are also to receive one issue of pay for creating the membership roster.
